TECHNICAL MANUAL CH401M4



1. Take note of how CH101M4 is stored within Carry Bag. This will be useful when breaking unit down. Handles are stored in stanchion holes (2nd) from top and are reversed for storage.



3. Take one handle out of storage position and slide into hole in top bracket as pictured.(see inset) Handle grip should be on the side of the wide frame or the front of the cart.



2. Undo straps and remove wheels



4. One handle is now in set up position.





5. After both handles are positioned as shown, remove Axles from axle pouches at bottom of bag.




6. Loosen axle clamps (close up) and slide axles into place. Twisting axles into place prevents "jacking". Secure Axles by tightening axles clamps when axle grooves match outside stanchion edge and hole in end of axle faces up. (see close up of axle clamp and axle).



7. Place second axle in the other stanchion in the same manner.



8. Pull frame into position by sliding frame out until it stops. It should move slightly outside the carry bag edge.



10. Place locking pin as shown for each side of cart, making sure the pin is inserted all the way in and through each frame piece.





9. Go to other side and slide the front frame out until it stops. Frame is now in position to be locked in place by a/inch quick release pin that is fasten to the side of each rail by a lanyard.

11. Remove Rue Pins (Axle Pins) from pouch on top of canvas carry case. Location shown in picture. Place a wheel on each axle end. Secure Wheel onto Axles with Rue Pins, making sure Rue Pins face upward as shown. To install Rue Pins push into hole at end of Axle and they will snap secure. To remove Rue Pins, lift end of pin which has slight bend and pull. To secure Rue Pins in place activate optional manual lock.



12. Turn cart right side up on its wheels and place poly board in cart to form its bottom.



13. Slide handle out till it stops; rotate handle to up position. It should click into place and be in position to be locked in place with a 3/8 inch quick release pin that is attached to the middle of each side of the cart.





14. Insert locking pin with handle in upright position. Repeat for the other handle (slide out, rotate and insert pin).



15. Apply brake by pressing lever handle on brake assembly until it locks down. To release brake pull up on brake lever.






